**(\*) W3.5 – FLIGHT WINNERS SEEDING PROCESS for Semi Finals:**

Semi Final matches will be **Match 1**: The Flight Winner with the best overall record vs. the Second (2nd) Place team with the best overall record and **Match 2**: The Flight Winner with the second-best overall record vs. the Flight Winner with the third best record.

All undefeated teams are compared first using the following tie-breaks:

1. The winner of the most individual wins.
2. The loser of the fewest sets.
3. The loser of the fewest games.

After all undefeated teams are seeded, then the teams with 1 loss are seeded, then 2 losses, etc.... Same method for breaking ties as used for undefeated teams.

Winners advance to **FINALS**.
